



Child Poverty Defined, 2021

- Poverty level
 - \$21,831 for a family of 3
 - \$27,479 for a family of 4
- 2020 Rhode Island Standard of Need
 - Single-parent family with 2 children would need \$57,671 a year to meet its basic needs, which would require a pre-tax income of \$66,057 to meet this budget without governmental subsidies.



Poverty by Race/Ethnicity




Children in Poverty, by Race and Ethnicity, Rhode Island, 2016-2020

Average Cost of Rent of a Two-Bedroom Apartment, 2017-2021



Homeless Children


- In 2021, 242 families with 508 children stayed in a homeless shelter or a domestic violence shelter in RI and as of January 2022, 153 families with 283 children were on wait list.
- During the 2020-2021 school year, Rhode Island public school personnel identified 1,109 children as homeless.
- Bristol Warren Public Schools personnel identified
 22 children as homeless.





Children in Families Receiving Cash Assistance

Cash Assistance Caseload, Rhode Island, 1997-2021*




- The Rhode Island cash assistance caseload has been steadily declining since the program began.
- The goal of the RI Works program is to help very low-income families meet their basic needs by providing cash assistance and work supports, including employment services, SNAP benefits, health insurance, and subsidized child care.
- The maximum monthly benefit for a family of three is \$721 per month. In 2021, benefits were increased for the first time in 30 years, but maximum benefits are still less than 50% of the federal poverty threshold.



Children Receiving SNAP Benefits





- Of the 139,787 Rhode Islanders enrolled in SNAP in October 2021, 69% were adults and 31% were children
- As of October 2021, 231 children in Bristol and 278 children in Warren received SNAP benefits.
- Receiving SNAP benefits decreases food insecurity and improves short and long-term health outcomes as well as high school graduation rates and adult earnings.



The School Breakfast Program

- Universal School Breakfast Programs, which provide free breakfast to all children regardless of income, increase school breakfast participation. All schools in Rhode Island offered universal free breakfast during the 2020-2021 and 2021-2022 school year, due to the pandemic.
- Making breakfast part of the school day is another proven strategy for increasing breakfast participation, reducing stigma, and increasing convenience.








Children's Health Insurance





- In 2019, 1.9% of Rhode Island's children under age 19 were uninsured. Rhode Island ranks second best state in the U.S., with 98.1% of children covered. In 2019, 64% of Rhode Island children under age 19 were covered by private health insurance, most of which was obtained through their parents' employers
- Approximately 60% (2,631) of the estimated 4,407 uninsured children under age 18 in Rhode Island between 2016 and 2020 were eligible for RIte Care coverage based on their family incomes but were not enrolled (some due to immigration status).



Children's Mental Health




In Rhode Island:

- ➤ 19% of children ages 6-17 has a diagnosable mental health problem and 10% have a significant functional impairment.
- > 33% of children ages 3-17 who needed mental health treatment or counseling had trouble getting needed care.
- ➤ In 2019, 15% of Rhode Island high school students reported attempting suicide in the past year.
- > From FY 2019 to 2021, the number of calls to Kids' Link, the state's behavioral health triage service and referral network has doubled
- ➤ In 2020, 467 teens ages 13 to 17 were admitted to the emergency department after a suicide attempt.
- ➤ In 2020, 334 teens ages 13 to 17 were hospitalized after a suicide attempt.



Babies Born






- Births have been declining for the past decade, both nationally and in Rhode Island. In 2020, the U.S. general
 fertility rate hit a record low at 56.0 births per 1,000 women ages 15-44.
- There is an increasingly diverse child population both in Rhode Island and nationally. In 2019 in Rhode Island,
 44% of babies born were Babies of Color.



Evidence-Based Family Home Visiting





34 families in Bristol and **12 families in Warren** were enrolled in Healthy Families America and Parents as Teachers home visiting programs in 2021.





- In Rhode Island in 2019, 8% of high school students reported not going to school due to safety concerns.
- In 2019 in Rhode Island, 20% of middle school students (27% of females and 15% of males) and 13% of high school students (17% of females and 9% of males) reported being electronically bullied.


Youth Referred to Family Court

Youth Referred to Family Court




 Of the 2,858 wayward and delinquent offenses for which youth were referred to Family Court in 2021, 6% were for violent crimes.



Youth in the Juvenile Justice System






- 87% decline in youth in the care and custody of the Training School from 2008 to 2021 after a cap was placed on the population in July 2008.
- In 2021, 3 youth from Bristol and 2 from Warren were at the Training School and 4 youth from Bristol and 5 youth from Warren were on probation.



Child Neglect and Abuse




Victims of Child Neglect and Abuse per 1,000 Children, 2021

 About half (43%) of the victims of child neglect and abuse in 2021 were young children under age six and one-third (32%) were ages three and younger.








High Quality Early Learning Programs

In Warren:


Of 5 child care centers, 60% (3 of 5) participate in BrightStars and 40% (2 of 5) have a high-quality rating



Head Start or RI Pre-K









- In Bristol, 13% of all 4-year-olds and 49% of low-income 4-year-olds were enrolled in either Head Start or RI Pre-K.
- In Warren, 27% of all 4-year-olds and 86% of low-income 4-year-olds were enrolled in either Head Start or RI Pre-K.

Third-Graders Meeting Expectations in English Language Arts, 2019 and 2021





Eighth-Graders Meeting Expectations in Math, 2019 and 2021



Chronic Early Absence





In Bristol Warren, 21% of K-3 students missed 18+ days of school during the 2020-2021 school year, similar to the state rate of 22% and up from 11% in 2019-2020.



Chronic Absence, Middle School and High School

- Bristol Warren's chronic absence rate in middle school was 26% during the 2020-2021 school year (similar to the state rate of 29%), up from 16% during the 2019-2020 school year.
- The **high school** chronic absence rate was **40%** (higher than the state rate of 34%), up from 24% the previous year.



- In 2016, the Rhode Island General Assembly passed a law that restricts the use of out-of-school suspensions to situations when a child's behavior poses a demonstrable threat that cannot be dealt with by other means.
- During the 2020-2021 school year, Bristol Warren had 4 suspensions per 100 students (120 disciplinary actions),
 among the highest in the state, and 86% of suspensions were out-of-school suspensions.



High School Graduation Rate, 2017-2021



Of the 260 Bristol Warren students who entered 9th grade in the 2017-2018 school year and were expected to graduate in 2021, **90% graduated in 4 years**, 3% dropped out, <1% obtained a GED, and 7% were still in school.






College Preparation and Access

72% of Bristol Warren students who graduated from high school in the Class of 2021 immediately enrolled in college, up from 64% for the Class of 2019.




